NAIC Annuity Suitability Regulation

Compliance with the NAIC new suitability training requirements is the basis for exemption from federal securities regulation. The new model regulation shifts the carrier responsibility from reviewing the agent's recommendation and determining it is reasonable, that it is suitable, and that is followed the suitability guidelines to the carrier being responsible for the product recommendation given for the client's situation.

As a result of this change, below are the guidelines for meeting the annuity training requirements associated with Suitability Model Regulation.

Prior to the sale, solicitation or negotiation of Company annuity contracts, all Insurance Producers selling or soliciting Individual Annuity Products must:

- 1. Complete Company provided product specific training.
- 2. For states that require a one-time four (4) credit hour annuity training course by an approved training provider, the Insurance Producers selling or soliciting Individual Annuity Products must complete the course and ensure the company receives confirmation of completion.
